On 6-20-2013 at approximately 1100 I met with SGT G DAVIS in reference to a complaint that came into APD regarding someone interfering with people gathering signatures at two different locations over the previous weekend, both at the park strip and Barnes and Nobles mid-town.

CONTACT WITH PATRICK LAVIN (RECORDED)

I called PATRICK LAVIN who indicated on his paperwork that he was the campaign coordinator for the issue trying to get on the ballot. I identified myself and gathered the following information, LAVIN indicated that he got word that a female had been steering people away from the signature gatherers and even placing her hands on the people and pushing them away from the signature gatherers.

LAVIN provided me with two names of people who were gathering signatures that day and could provide more detailed information on what actually took place, the first person was a WILLIAM BUCHWALD and the second was a PATRICIA ANDERSON, all the contact information he had for both parties was a phone number for **BUCHWALD** and an email address for ANDERSON.

I provided case numbers to LAVIN and indicated I would be starting the investigation into the allegations.

I arrived and after talking to WILLIAM BUCHWALD and confirming it was the same female I went up and talked to her.

I introduced myself and asked if I could talk to her, she very cordially advised yes and stepped over so we could talk, myself and SGT DAVIS had been watching how she was conducting herself and saw no issues with it and I explained that to her when I first started talking to her, I advised her that I was following up a complainant that she had been physically putting her hands on the shoulders of voters who were voting yes on the petition, she stated that what actually happened was that she was talking to people prior to them going up and signing their name on the petition, she stated that the male who was present today gathering signatures "WILLIAM" was actually interfering with her by stepping between her and the people as she was trying to explain the issues and why they should not sign the petition.

I asked HETEMI what BUCHWALD was doing and she stated he would get between herself and the voter and actually back into her and push her away from the person that she was talking to, at no time did she ever get physical or put her hands or use her body in any way to sway a voter like BUCHWALD was doing, I told HETEMI I appreciated her talking to me so I could get her side of the story, I provided HETEMI with case numbers for the incident.

INTERVIEW WITH LEROY POLK (NOT RECORDED)

As I was getting ready to leave LEROY POLK walked up to my car and asked if I needed to talk to him, I asked what his involvement was and he stated that he is a security guard at Barnes and Nobles and was working the day that the two parties had their issues, he stated that he never saw the female HETEMI get physical with anyone although she was pretty "adamant" with her body language that she did not want people to sign the petition, I asked specifically if POLK saw HETEMI place her hands on anybody and he indicated that he did not see that and he was present for the entire day when the signature gathering was going on.

ADDITIONAL INFORMATION

As of 6-20-2013 at 1354 I had not received any call back information on PATRICIA ANDERSON who LAVIN stated was also present when the allegations against HETEMI were made, At approximately 1700 ANDERSON returned my phone call.

INTERVIEW WITH PATRICIA ANDERSON (RECORDED)

I called back ANDERSON who stated she was gathering signatures on the park strip on Saturday the 15th, she described a female who matched HETEMI'S description approaching her as she was gathering signatures and telling the people not to sing the petition and to educate themselves before they sign it, she also stated that they could go on line and remove their signature if they wished, ANDERSON stated she talked to about 5 groups of people and each time the female did the same thing, ANDERSON indicated nothing physical happened and when ANDERSON told the female "you are interfering with my 1st Amendment Rights" the female left and didn't bother her again.
